FREQUENTLY ASKED QUESTIONS

1. YOU MAY SETUP AFTER 6:00 P.M. (NO EARLIER SETUP WILL BE PERMITTED) ON THURSDAY, SEPTEMBER 29, or FRIDAY, SEPTEMBER 30 BEFORE 8:30 A.M. PLEASE SEE Krista Jackson (606) 369-1283 FOR YOUR ASSIGNED LOCATION.
2. NO VEHICLES WILL BE ALLOWED IN THE AREA ANY OTHER TIME, (SEE #3 BELOW). IF YOU ARE CARRYING YOUR ITEMS OUT AT THE END OF THE DAY, YO WILL NEED TO MAKE OTHER ARRANGEMENTS OTHER THAN USING A VECHICLE TO CARRY THEM OUT. THERE WILL BE NO SECURITY. IF YOU LEAVE YOUR ITEMS OVERNIGHT, IT WILL BE AT YOUR OWN RISK.
3. YOU MAY CLOSE DOWN AT ANY TIME DURING THE FESTIVAL. HOW EVER, IT MAY BE DIFFICULT TO GET VEHICLES ON THE STREET BECAUSE OF THE CROWD. NO VEHICLES WILL BE ALLOWED IN OR OUT UNTIL AFTER THE PARADE ON SATURDAY. THE PARADE IS USUALLY OVER BY 5:00PM.
4. NO REFUNDS ON “NO SHOWS” OR FOR “INCLIMATE WEATHER”.
5. YOU SUPPLY EVERYTHING THAT YOU WILL NEED TO SELL, OR DISPLAY YOUR PRODUCT; IF: TENTS, AWNINGS, TABLES, ETC. YOU ARE RENTING “OPEN AIR ON THE STREET SPACE” ONLY.
6. WE RESERVE THE RIGHT TO LIMIT THE TYPES OF ITEMS SOLD AND THE NUMBER OF MERCHANTS WITH DUPLICATE RETAIL ITEMS. IT IS IMPORTANT THAT YOU RETURN YOUR APPLICATION AS SOON AS POSSIBLE. (PLEASE NOTE DEADLINE FOR APPLICATIONS.)
7. NO CONCESSION (FOOD) ITEMS WILL BE PERMITTED FOR RETAIL.

8. NO FIRE WORKS, NO INFLATABLES, & NO SILLY STRING ARE ALLOWED TO BE SOLD. PLEASE SEE A LIST OF **BANNED** ITEMS ON OUR WEB SITE., www.kyapplefest.org
9. IF YOU WILL BE UTILIZING ELECTRICITY, YOU MUST USE ONLY **ONE** EXTENSION CORD PER RECEPTABLE (NO CORDS CAN BE COMBINED TO REACH WHATEVER YOU ARE SENDING POWER TO) AND IT **MUST** BE APPROVED FOR OUTDOOR USE.
