Dear Flea Market Vendor,

The Kentucky Apple Festival will be held this year on October 5<sup>th</sup> and 6<sup>th</sup>, 2012 in Paintsville Kentucky. We would like to invite you to participate in the Flea Market. The Flea Market will be located in the main city parking lot and other spaces available. We will have electric hook-ups for each lot. If you need electric service, please indicate this on your registration form.

The Cost for Spaces will be as follows:

10 ft x 10 ft --- \$125.00  
10 ft x 20 ft --- \$200.00  
10 ft x 30 ft --- \$275.00  
10 ft x 40 ft --- \$350.00  
10 ft x 50 ft --- \$425.00  
10 ft x 60 ft --- \$575.00

A \$50.00 deposit must be paid along with your registration form by June 1, 2012. The rest of the balance must be paid by September 1, 2012 and if you have a reserved space, the balance must be in by this date or the space will be re-assigned and no fees will be returned.

After September 1, 2012, a confirmation letter will be sent to you stating the date and time for you to set up your booth. You need to register early because spaces are limited. After all spaces are filled, you will be put on a waiting list. **No one will be allowed to set their booth up until their fee is paid. Also, a registration table will be set up to pick up your permit to operate your booth.** You may register by sending a money order or certified check for the rental fee to the Kentucky Apple Festival.

Dear Vender,

In the interest of the safety and comfort of the festival visitors, the following is a detailed list of items that cannot be sold during the Kentucky Apple Festival.

1. Fireworks of any kind.
2. Any obscene merchandise.
3. Boot-legged merchandise
4. Exploding toilet seat.
5. Vanishing Ink.
6. Party string.
7. Bomb Bags.
8. Stink Bombs
9. Snap-n-pops.
10. Colored Hair Spray.
11. Laser Lights.
12. Any type of martial arts supplies.
13. Knives or Firearms; Exceptions are collectors knives. Ex: UK Wildcat Collectors, Coal Miners Daughter, etc. Collectors knives can only be sold to persons who are 18 years or older (NO MINORS).
14. Balloons and inflatable items. They are to be sold by Dealers franchised by the Board of Directors. Balloons and inflatable items are not to be given away as prizes. Exceptions to this rule are water filled Yo-Yos, Sports Balls such as basketballs, Soccer balls, etc. Balloons given to the Apple Festival Visitors by various businesses or organizations free of charge for information purposes shall be exempt to this rule.
15. Potato guns.
16. Marshmallow guns.
17. Any live animals, reptiles, or snakes.
18. Sling shot or any kind of projectile.
19. Rubber Bands.

The proceeding list will be strictly enforced during the Festival. If you wish to not comply with any item on this list, you will not be allowed to participate in future Apple Festivals as a vendor.

Any vendor who wishes to place a bid on the Balloon franchise should place a written bid to the board of directors at least two months after the close of this festival. The franchise will be awarded to a vendor who will then sign a binding contract for the next Festival.
